In accordance with Standing Orders, in the case of an Annual Meeting in an election year and until the election of the Cathaoirleach at such meeting, the Chair for this period shall be taken by a member or an employee selected by the meeting for this purpose. On the proposal of Cllr. M. Sheehan, seconded by Cllr. L. McDonald, Cllr. J. Fleming was selected to Chair the meeting.

Cllr. J. Fleming welcomed the Members, Minister J. Browne, Deputy P. Kehoe, Deputy J. Mythen, Senator M. Byrne, and all present to the Annual Meeting of Wexford County Council.

Those present observed a minute's silence to mark the passing of John Whyte, uncle of Cllr. A. Donohoe.

1. Election of Cathaoirleach

Cllr. P. Breen was proposed by Cllr. D. Kenny and seconded by Cllr. O. Walsh for the position of Cathaoirleach.

Cllr. P. Barden was proposed by Cllr. P. Kavanagh and seconded by Cllr. M. Murphy for the position of Cathaoirleach.

Cllr. T. Forde was proposed by Cllr. J. Codd and seconded by Cllr. A. R. O'Brien for the position of Cathaoirleach.

On a show of hands, 22 voted in favour of Cllr. P. Breen, 6 voted in favour of Cllr. T. Forde, 5 voted in favour of Cllr. P. Barden, and Cllr. L. Kelly abstained. Cllr. J. Fleming deemed Cllr. P. Breen to be elected Cathaoirleach of Wexford County Council for the 2024-2025 term.

Cllr. P. Breen was presented by Cllr. J. Fleming with the Chain of Office, following which Cllr. P. Breen assumed the Chair. Cllr. P. Breen presented Cllr. J. Fleming with a certificate and County crest to mark his tenure as Cathaoirleach.

Cathaoirleach P. Breen acknowledged the presence of Minister J. Browne, Deputy P. Kehoe, Deputy J. Mythen, and Senator M. Byrne. Cllr. Breen thanked his proposer and seconder, and congratulated Cllr. J. Fleming on his term of office.

Cllr. Breen thanked those who voted for him and those who didn't, acknowledging that this is democracy in action. Cllr. Breen welcomed the new Members and sympathised with those who lost their seat.

Cllr. Breen emphasised his commitment to the betterment of Wexford and expressed his faith in the Executive and staff of Wexford County Council.

The Members and Chief Executive joined in congratulating Cllr. Breen on his election to the position of Cathaoirleach and wished him every success in the year ahead.

2. Election of Leas-Cathaoirleach

The Cathaoirleach called for nominations for the position of Leas-Cathaoirleach of Wexford County Council.

Cllr. G. Carthy was proposed by Cllr. F. Staples and seconded by Cllr. J. Codd for the position of Leas-Cathaoirleach. As Cllr. Carthy was the only nomination, Cathaoirleach P. Breen deemed him to be elected to the position of Leas-Cathaoirleach of Wexford County Council.

Cllr. G. Carthy was presented with the Leas-Cathaoirleach Chain of Office by Cathaoirleach P. Breen.

Cllr. Carthy congratulated Cllr. P. Breen on his election as Cathaoirleach and his great service to Wexford. Cllr. Carthy thanked his proposer and seconder, and acknowledged the great honour it is to serve his county.
