Housing Strategy & Services

Under the Housing for All Programme 2022 to 2026, Wexford County Council must deliver a minimum of 1,159 new housing units within the programme timeframe. The status of overall programme delivery is contained in the diagram below.

It is the Councils intention to continue to deliver new housing, above the target provided under the programme, where demand exists and Department funding is available.

Turnkey Delivery

The Housing Section periodically seek Expressions of Interest for the provision of social housing units via Turnkey Acquisition. A new Expression of Interest opened on the 8th January 2025. All calls are seeking targeted delivery of smaller unit types (1 & 2 beds) in areas of need identified in the Housing Delivery Action Plan (HDAP). In addition, the process also seeks proposals for purchase of land in areas of need. All proposals received by Wexford County Council under the turnkey process are assessed by an Internal Assessment Committee.

Energy Efficiency Retrofitting Programme

Energy Efficiency Retrofit Programme 2024 is the fourth year of a new 10-year Energy Efficiency/Retrofit Programme to retrofit local authority housing stock. The new programme provides for a significant upscaling in the level of funding available and focuses on ensuring that the fabric of the home is upgraded, and an energy efficient heating system is provided. The table below outlines the targets set by the Department for Wexford to date.

Housing Maintenance Section completed energy upgrades to 146 properties in 2023. Completing the balance of our 2021 to 2023 targets in 2023. The value of the grant funded works for 2023 was €3.99 million.

The 2024 allocation has been received from the department with an approval given for a target of 116 units: 126 of which have been completed.


AFFORDABLE HOUSING



Affordable Housing Application Portal Launch February 2025.

Wexford County Council is about to launch the pilot affordable housing scheme in Ramsfort, Gorey, county Wexford.

The development which is being constructed by Mythen Construction in partnership with Wexford County Council, will provide new homes for sale via Wexford County Council's 'local authority affordable purchase' scheme.



These homes will be available at a reduced price for buyers who are seeking to purchase a newly built home but need to bridge the gap between their mortgage and deposit to cover the full price of the home.

Applications will be only accepted via the online application portal which will be available from 10.00am on Wednesday, 12th of February 2025

Income limits apply and potential applicants are strongly advised to familiarise themselves with the qualification criteria and the documentation required, details of which are available at - https://www.wexfordcoco.ie/housing/affordable-housing/local-authority-affordable-purchase-scheme

Local Enterprise Office

Local Enterprise Office (LEO) Wexford celebrated its 10th anniversary on Monday, December 9th at Wexford County Council marking a decade of growth, innovation, and support for the local business community. Cathaoirleach of Wexford County Council, Pip Breen opened the event which featured a festive market and craft fair, bringing together products from client companies many of whom are members of the Wexford Food Producers Network, local craft producers and students participating on the Student Enterprise Programme. Wexford LEO is ranked in the top 3 nationally re job creation.

10 YEARS OF LEO CELEBRATION





Over the past decade, LEO Wexford has played an instrumental role in fostering entrepreneurship and supporting local businesses. The office has helped create 2,895 new jobs across various sectors, boosting the local economy. Through its programs, including Local Enterprise Week, National Enterprise Awards, National Women's Enterprise Day, and youth-focused initiatives like Ireland's Best Young Entrepreneur and the Student **Enterprise** Programme, LEO Wexford has empowered entrepreneurs at every stage of their journey.

More than 12,540 students from across County Wexford have participated in the Student Enterprise Programme, gaining practical experience in running their own businesses.



10 YEARS OF LEO CELEBRATION CONT'D

LEO Wexford has provided critical financial support to local businesses, administering over €6.58 million in grant aid to 234 manufacturing and internationally traded service companies. Additionally, 18 businesses have been transferred to Enterprise Ireland for further export support. LEO Wexford's Trading Online Voucher Scheme has helped 990 local businesses secure €2.11 million to develop new online revenue streams, a vital shift accelerated by the pandemic.



SUPPORTS FOR BUSINESS

Operational efficiency, digitalisation and sustainability of SMEs are key priorities in the White Paper on Enterprise 2022 and reiterated in LEO Policy Statement 2024-2030.

As part of the SLA with Enterprise Ireland, LEO Wexford are tasked with delivering consultant led support services under the Lean for Business, Green for Business and Digital for business programmes.

The Local Enterprise Office received 47 submissions in response to a Request for Tender to establish a framework to deliver the LEAN, Green and Digital for business programmes.

These programmes are available to both new and existing businesses and are designed to match small business owners/ managers with experienced, insightful business members that can provide them with practical and strategic advice and guidance in relation to specific challenges their business needs to overcome.

SHOWCASE 2025

The Local Enterprise stand at Showcase, is a national initiative to support small businesses from the craft and design sector. The Showcase exhibition, which is Ireland's premier design and craft fair, takes place in the RDS Dublin from 19-21st January 2025 and is an opportunity for Irish makers and creators to meet and sell to domestic and international buyers.

Wexford LEO has selected 5 clients to participate at Showcase this year in the Enterprise Hall.

Now in its second year The Local Enterprise Office (LEO) Business of Craft Awards are open to all the LEO clients exhibiting at Showcase as part of the Local Enterprise Showcase.

The awards have four award categories:

- 1. Best Newcomer for the best craft and design business exhibiting for the first time.
- 2. One to Watch for the best craft and design business who has excellent export and international potential.
- 3. Sustainability Champion for the best craft and design business who is excelling in sustainability



This year also sees an additional award for Best Visual Business. This will be judged at the event and will be awarded to the craft and design business with the best visual presence and branding both at the event and across their online channels.

In 2024 Wexford business, Sully and Juno won best newcomer at the Business of Craft Awards.




Tourism Ireland launch 2025 Marketing Plans



Planning Applications received year to date - 1st January to 31st December 2024





Work is ongoing on the Chief Executive's Report on the achievement of the objectives of the Plan. The Plan contains over 1,200 objectives covering the Council's key programmes, activities and projects, and monitoring ensures that these objectives are being met as set out.



Wexford Town Local Area Plan

Work on the Wexford Town Local Area Plan continues. The LAP team are progressing the development of the overall spatial planning framework for the town. A key component of the framework is the Urban Design Strategy, and the consultants Loci are progressing well with this complex work. A Town Centre First Strategy is being prepared and a Town Team comprised of representative stakeholders has been formed to inform and guide that strategy.

Wexford Town Local Area Plan Cont'd

The LAP Team are currently reviewing a report received from MacCabe Durney Barnes 'Wexford Town – An Economic and Market Review' which will also inform the preparation of the strategy. The consultants working on the Rainwater Management Plan and the Green Blue Infrastructure strategy are currently reviewing and incorporating the feedback from the LAP team.





Town Centre First

There are 7 Town Centre First Teams active in 7 Towns in County Wexford with each Town at different stages of the Town Centre First journey and funded through the 2024 TCF Suite of Supports.

Measure 1 - Under this measure we have successfully established town teams in Taghmon, Bunclody and Castlebridge and completed health checks for all towns.

During January/February the focus will be on further capacity buildings in these Towns with talks organised by leading urban regeneration experts, along with site visits to exemplar towns, community events along with website enhancements in an effort to communicate more effectively with the wider community.

Measure 2 - We are working closely with the Courtown/Riverchapel TCF Team to develop at TCF Plan for Courtown/Riverchapel. We have 2 consultation events in January 2025.

On the 23rd of January we will be inviting all secondary school children for the area to a workshop consultation to ensure their views and ambitions are reflected in the plan. On Sat 25th we then have further consultation with the wider community with walk and talk sessions designed to get feedback from the wider public on findings of the SCOT analysis. These will be publicised in the coming days.

Measure 3 - Work in ongoing with the Projects development measures for these 2 €50k projects with consultants due to be appointed in the coming days. The successful groups are 1. Feachtas Ealaian- T/A St Michaels Theatre 2. Kilmore Scope.

Vacant Homes

Work is continuing on vacant homes with the administration of the Croi Conaithe Grant. The Regeneration Unit is continuing to promote the scheme and work with applicants in getting projects approved and paid out.

There has been huge uptake in County Wexford, and it is having a very positive impact on improving vacancy and dereliction.

READY TO BUILD

In relation to Ready to Build we are looking at some possibilities for 2025. Brief details of Ready to Build are as below,

- Local authorities will make available serviced sites at reduced cost to support self-build home ownership.
- The level of discount to the individual will depend on the level of servicing cost incurred by the Local Authority before the sale of the site but will not exceed €30,000 (being the max amount the Local Authority can claim from Department to get services to the site).
- Have direct access to adequate mains water supply and mains wastewater disposal infrastructure.
- Local Authorities will manage the prioritisation of applicants in line with the framework of priorities as outlined by Department of Housing, Local Government and Heritage.

MAJOR NATIONAL ROADS PROJECTS

N11/N25 Oilgate to Rosslare Harbour

The Project is in Phase 3 – Design and Environmental Evaluation.

Tender submissions for Real Estate Consultancy Service are being reviewed with a view to appointing the successful bidder in Q1 2025.

Detailed project design is developing, including provisions for an on-line service area and active travel. Stakeholder engagement is ongoing.

N25 Rosslare Europort Access Road

The Project is in Phase 5 – Enabling and Procurement with the preparation of the procurement package for publication in Q3 2025.

Coordination with OPW/Irish Rail in relation to the OPW/Irish Rail temporary works and N25 Rosslare Europort Access Road is ongoing.

SPEED LIMIT REVIEW



Phase 1: Implementation of the new 60km/h Default Speed Limits

The effective date for the implementation of Phase 1 of the 60km/hr default speed is 7th February 2025.

Preparatory works are in place for this implementation date. Some signs may be covered until the effective date.

The Department of Transport advised that a provisional date of June 2025 has been set for the new urban speed limits and the implementation of the necessary Bye Laws. Information Sessions / Workshops will be scheduled with all Councillors early in 2025.

ROAD SAFETY

Just 1 Life

Our joint Road Safety programme of events in association with Wexford Rotary Club, Just 1 Life (J1L) commenced on the 11th of December 2024 with approximately 400 attendees from 5 Secondary Schools.

Four more J1L events are planned in January, February, March and April and all Elected Members are welcome to attend any of these event dates. Presentations include An Garda Siochana Roads Policing Unit, Wexford Fire Service, National Ambulance Service, HSE Accident and Emergency Staff and Wexford Mental Health Association.

PUBLIC LIGHTING

<u>LED Upgrade (Non-National Roads)</u> - Works commenced on the final phase of LED lanterns replacement works. 33 No. lanterns were replaced on the R700 (Old N30) New Ross from Kents Cross Roundabout to Irishtown.

It is planned to have public lighting fully upgraded to LED by the end of 2025.



Enniscorthy Technology Park Phase 2 - The Technical Consultancy Services Contract has been awarded to Tobins for Stage (i) to (v) design services. Design work and site investigation will commence in Q1 2025.

Enniscorthy Technology Park – IDA Advance Factory Building - Tenders have been received for an architect-led design team to prepare a planning application for a proposed advance factory building in Enniscorthy Technology Park. Tender assessment is complete and appointment is imminent.

Dunbrody Centre Extension - A tender for the procurement of a consultant to undertake Stage (i) to (v) design services for the extension of the Dunbrody Centre is being prepared. It is anticipated the Tender will be invited under an existing framework in January 2025.

South East Greenway - The works are nearing completion for Lot 5a, a 5.5 km section from Ferrybank to Curraghmore. A Stage 3 Road Safety Audit and some subsequent works will be required in advance of opening of that section which is targeted for end of Q1 2025.

Murphy Floods Redevelopment - John Tinnelly & Sons were appointed as works contractor in September 2024. Works were completed on site in mid-October.



COMMUNITY & SPORTS ACTIVE

The Local Economic and Community Plan (LECP) 2024-2029 was officially launched at the December meeting of Wexford County Council on 9th December 2024.



The Wexford LECP 2024-2029 sets out 6 ambitious High-Level Goals which are supported by a series of actions and objectives which aim to deliver an ambitious plan to transform the lives of County Wexford's residents. The Plan also includes an initial 2-year implementation plan, detailing which actions are to be prioritised for the first two year period. The plan is now available to be downloaded from the council's website at www.wexfordcoco.ie

The Department of Rural and Community Development has announced the **Local Enhancement Programme (LEP)** which provides funding to support community groups across Ireland.

The Local Enhancement Programme 2025 will support groups with funding to carry out necessary repairs and improvements to their facilities, and to purchase equipment for example tables and chairs, tools and signage, laptops and printers, lawnmowers, canopies and training equipment etc. Facilities improvement works may also include, but are not limited to; improved access for persons with a disability; enhancing community participation for disadvantaged and marginalised groups, and; improving energy efficiency of community facilities to reduce ongoing costs.



In total for County Wexford, €217,051 is available to fund capital works and new equipment, and €36,175 is available to fund non-pay running costs. Applications under the capital fund are capped at €5,000 per community group, whilst applications for non-pay running costs are capped at €500 per community group.

Applications for the programme opened on 8th January, and are available online at www.wexfordcoco.ie

Proposed applications under the Local Enhancement Programme should demonstrate how they will contribute to the objectives contained within the 2024-2029 Local Economic and Community Plan.

WEXFORD SLÁINTECARE HEALTHY COMMUNITIES PROGRAMME (SHCP)



On the 20th November The SHCP Co-ordinator along with the Healthy County Co-Ordinator got to meet with teams from Emergency Management and the Institute for Health Logistics & Analytics of **Georgia Southern University** to share their work and to hear about work happening in their communities. They also discussed OneHealth and shared challenges and opportunities.



Following the success of the **Ferndale Street Soccer** project, funding has been secured from the Dept. of Health to continue to run the project for another 8 weeks on Saturday mornings on the new astro pitches. Youth workers and community Gardai have committed to continue to attend and participate.

Grind classes started in Taghmon FRC on 2nd December with Junior Certificate and Leaving Certificate students from Colaiste Abbhain, Adamstown receiving grinds in Maths and English funded by the Slaintecare Healthy Communities Programme. The grinds will continue up to the end of the school year with additional revision classes planned for pre-exams. This initiative is a joint project between Taghmon FRC, Colaiste Abhain and Wexford County Council's Slaintecare Healthy Communities Programme.

AGE FRIENDLY WEXFORD



The Older Person Council had its last meeting of the year in December and Angela Cassidy vice chair of the Older Person Council reported on the walkability Audit that took place on 25th November and informed the Council that the second part of the audit will take place on 14th January to take in a route along the Quay front.



The Age Friendly Alliance also had its last meeting for the year, it was Chaired by the Chief Executive Eddie Taaffe and the members from the HSE, Local Link, WWETB, Library Services etc provided updates on the services they offer. The dates for the 4 meetings in 2025 were set at the meeting.

A brochure is currently being compiled on the Age Friendly programme in Wexford and the final part of it was to have a picture of the Older Person Council, the brochure then will be available for distribution at events in the New Year.

HEALTHY WEXFORD



The **Healthy County Committee** elected Cllr Leonard Kelly as the Committee Chair at their December meeting. The committee also updated its Terms of Reference reflecting updated membership.

Working group activity continues with the **Mental Wellbeing Working Group** and **Not Around Us Working Groups** meeting to review activity and plan for 2025. Both groups will meet again in January to finalise their 2025 plans.

While the 2024 activities came to an end **Healthy Ireland Fund Round Four partners** have been busy collating 2024 Financial Claims.

Additional **Healthy Ireland funding** of €35,000 was received for 2025 and the Healthy County Committee have agreed allocation to additional Playful Spaces projects. This allocation is subject to Wexford LCDC approval at their next meeting. Project reviews were also completed in December for both of the pilot programmes - the **Healthy Home Environments** project and the **Womens Healthy Through the Ages** (The Healthy Choices Programme).

Work continues on the **Period Dignity Project** with Wexford County Council supporting product provision in County Hall and a at Wexford Public Libraries. 2024 funding also allowed for some project extension to locations not supported through other funding and so a pilot extension to Homesless Services and Wexford Womens Refuge has commenced.



Promotion of product locations (including some not directly supported by Wexford County Council) was one of the key 2024 activities for 2024 funding also and this has been progressed through creation of a product locations flyer and via print and social media advertising. Further promotion is planned for January 2025 to include radio and creation of a product locations animation to be utilised across social media.

The **Cultural Companions** initiative was re-launched at an event in County Hall on 5th December. Healthy Wexford has been working in partnership with the Arts Department, Age Friendly Wexford, Slaintecare Healthy Communities and Wexford LCDC on the resurgence of the initiative which is now open to all ages. With significant interest in the initiative on the night, a follow up meeting was held on 12th December to agree events for Q1 2025 and those who have signed up will receive details of same in late December





Healthy Wexford will continue to support the initiative during 2025 to help it get back up and running.

Healthy Wexford supported Wexford PPN to host another **Community Growers** Network Event in December where Horticturalist Aoife Munn provided advice on propagation, hard wood cuttings, and rainwater harvesting in addition to discussing health benefits of gardening and encouraging biodiversity and wildlife in the garden.

Beaches - Grange Beach Cliff Stabilisation works started in Oct 2024. The beach access is temporarily closed until the works are completed.

Coast - Seaview Coastal Protection and Beach Access, Kilmore: Total funding of €1.6m is now approved by the OPW. The contract was awarded to Stephen Byrne Plant Hire and Civil Engineering Contractors in October 2024 with works to start Jan 2025.

Drainage Districts - Kilmannock Drainage District, Great Island: consulting engineers appointed to progress repair, maintenance and health and safety works.

Low Smoke Fuel Areas - The 4 stations in New Ross, Wexford, Enniscorthy & Gorey have now had their monitors updated to measure air quality and noise levels. There are also 6 low cost sensors installed in Enniscorthy monitoring PM10 & PM2.5 only. UoG & UCC have started a programme called Open air to monitor gases NOx, SO2, CO continuously, particle numbers 10 nm to 10 microns, as well as black carbon and organic aerosol, ions ammonium, chloride, sulfate and nitrate, all in real-time, as well as collecting 24hr filter samples of PM2.5. The filter samples will be analysed for metals and toxicity. These will be compared with 2016 levels taking during the SAFFIRE project. They will be monitoring the weather also.

Agriculture - Wexford County Council continues to undertake a significant number of farm inspections in accordance with the WFD. Wexford County Council engage with landowners to undertake the necessary rectifications works through encouragement of improvement of farming infrastructure and farming practices.

Section 12 & 23 notices under the Local Government Water Pollution Act 1977-1990 were served upon farms where major non compliance are observed and cross reported to DAFM.

Under the National Agricultural Inspection Programme, Wexford County Council carried out a total of 169 farm inspections throughout the county concentrating in areas where water quality was most at risk of not meeting its objectives under the WFD.

In 2025, Wexford County Council will be required, under the NAIP, to carry out 270 GAP inspections where a team of 4 Assistant Scientists take on this role lead by the Agricultural Scientist in the Environment Section.

A total of 108 Agricultural related Planning Permission Applications were received in 2024 highlighting the continued investment in Wexford Agriculture and maintaining compliance with Good Agricultural Practice Regulations.

CLIMATE ACTION

DZ

A presentation on the Enniscorthy DZ was made to the elected members of the Enniscorthy MD by the members of the Climate Action team. The members were invited for feedback on progressing work in the DZ and recommended additional stakeholders to include in actions in the DZ. The meeting was very helpful.



The Climate Team attended workshops on Eco Literacy and the Climate Art Assembly on promoting and increasing awareness around the area of the Environment and Climate Action through culture and Arts.

The Climate and coastal sections are collaborating with TCD on the "House on the Beach" project at Rosslare. The project, led by Trinity College Dublin is a cross-border climate action project, to illustrate the urgency of the climate challenge. The project will place a sculpture of a house made from wood in 2 coastal locations – north and south for a short period in 2025. The sculpture is a metaphor for the houses we live in, the environment we live in and our planet – all of these are fragile and under urgent threat from sea level rise, forest fires, coastal erosions and climate change.

Locations for an EV charging Hub are being explored with Zero Vehicles Emission Ireland(ZEVI). ZEVI will provide 100% funding if a suitable location is agreed.

COMMUNITY CLIMATE ACTION PROGRAMME





The 16 successful projects have commenced works, with four groups having already completed significant elements of their projects. The second round of the Programme is expected in 2025.

Sustainable Energy Communities (SEC)

Wexford SEC and the Climate Action Team continued with the awareness promotion of the SEAI's Warmer Homes Scheme, which is a fully funded home energy upgrade grant for homeowners who meet certain social welfare criteria. A drop-in information afternoon was held on 7th November in Access 2000, Green St, Wexford and was very well attended.


Enniscorthy SEC on behalf of the SEC's within Co Wexford has submitted a funding application to the "Climate Actions Work Engagement Fund". The application is seeking funding of €10,000 to enable a training of "energy champions" across all SEC's. These champions would then inform and assist members of their communities with making grant applications for home energy upgrades.

Biodiversity

The Biodiversity Officer is currently working on bringing together a Biodiversity Working Group to develop a new Biodiversity Action Plan for County Wexford. The current plan expired in 2018. This plan will aim to provide a structured approach to biodiversity conservation at a local authority level. It will outline the objectives and actions needed to protect and enhance biodiversity within County Wexford.

There are now 27 registered Dog Breeding Establishments with several applications on hand awaiting inspection.

Forgotten Women Launch

Dr Niamh Shaw launched the publication of Forgotten Women - from Gorey to Antarctica published by the Gorey Age Friendly Alliance Quilting Group and supported by the WWETB Community Education Programme in Gorey Library. In Nov 2023, Dr Shaw joined 99 other Women in STEM leaders from across the world who shared a passion for climate change. After working with the Gorey Age Friendly Alliance Quilting Group in Gorey, to highlight forgotten Irish women scientists, Niamh carried their handmade quilt to the Antarctic in honour of these women. 45 attended.

Aileen Lambert, Commemorations Artist Bursary 2024 winner, entertained with New Songs: To tell the Story.



As a follow-up to Decade of Centenaries program, all local authorities were allocated €15,000 for Commemoration 2024. Wexford County Council invited applications for a Commemoration 2024 Artist Bursary. The aim of this project was to respond, with sensitivity, to the historical context of this period in County Wexford and to promote deeper а understanding of the significant historical events of one hundred years ago.

The successful project could use poetry, literature, music, theatre, and other art forms to explore 1924 and the early years of the State. The total fund allocated was €5,000 for one bursary. We received eight applications and formed a panel to assess these.

The successful artist and project was Aileen Lambert with New Songs: To tell the Story, a song and music project whereby Aileen developed newly composed songs in the traditional style and set some existing poetry to old airs/newly composed airs. Aileen performed her new songs and poems at an event in Wexford Town Library branch in December, 22 attended.

The Enniscorthy Carol - The premiere screening of the short documentary 'Enniscorthy's Carol' by Aileen Lambert took place in December in Enniscorthy Library. The project was the recipient of an award from Creative Places Enniscorthy, supported by Wexford Arts Centre, Wexford County Council and the Arts Council. Ordinary Objects from Ordinary Lives - Ireland's first century of Independence was held in Wexford Branch where Brenda Malone, Senior Curator National Museum of Ireland discussed plans for the National Museum exhibition to represent everyday life after independence was achieved.

Local Studies - Wexford Library had 17 genealogy enquiries and 24 local studies enquiries in December. The Wexford Great War Dead site had 4 enquiries, 2 corrections and 1 addition.

COMMUNITY AND CULTURE

Threads of Friendship Tapestry Launch - New Ross Library launched the exhibition Threads of Friendship. Led by experienced stitchers with the Ros Tapestry, this Creative Ireland Project taught sixteen stitchers crewel embroidery over four months. The new stitchers came from the local community and the international community, following outreach to many local groups.

Leabhair Filíochta Launch with Eamonn Kelly - In December, Gorey Library celebrated the Gorey Launch of 'Thug Mé Faoi Deara' with author and poet Eamonn Kelly, with support and performances from the Gorey/ Ballygarrett Comhaltas Group, 40 attended.

Quaver Piano School Christmas Concert and Gorey Choral Group Christmas Concert

The Winter Wonderland Music Display was hosted by the Quaver Piano School at Gorey Library this Christmas. The library also hosted Gorey Choral Group, a mixed choral group which has been singing together for over 40 years, 80 attended.



Reachability – Adult Literacy for Life literacy club. - Kilcannon Reachability hub concluded its weekly literacy club for their learners in Enniscorthy Library in December.

Partnerships - Wexford Local Development Elevate Progamme concluded its autumn sessions in December. Three groups met over two days for six weeks during the autumn / winter months in Enniscorthy Library. This programme focused in on creative writing with the Elevate book club participants to promote and support educational achievement in County Wexford. The programme is facilitated by author Caroline Busher. A short film promoting the Elevate programme was launched in December, https://youtu.be/RdthkoqZcNA

Festive Events Wexford Library - Wexford Library held festive events in December starting with a festive evening of music and song with singer Stephen Murphy, 22 attended.

The Chapter and Verse Collective – Choirs by Candlelight with MC John Bird continued the theme with four county Wexford based choirs (Chordiality, Ukrainian Song New Ross, Anam Choir and the Wexford Male Voice Choir), entertaining with festive tunes, 140 plus attended.

Seasonal events concluded with local storyteller Joe Brennan who shared stories of wonder and magic for the festive season, 16 attended.

Маланка - The Wexford Branch held a Ukrainian traditional performance for the folk holiday Manahka. The Manahka festivities were historically centred around house-to-house visiting by groups of young people, dressed as characters from a folk tale of pre-Christian origin. 60+ attended including Mayor Walsh

Living by the River by Pierce Turner - Living by the River, a book by renowned singer Pierce Turner, was launched by Brendan Howlin in Wexford Library in December. This is Pierce Turner's writing debut. 48 attended.

IT LITERACY

ALL Digital Skills for Everyday Life - This 5 week digital skills course held in the libraries, concluded in December. It was aimed at those who feel like they're being left behind because everything is online.

WWETB Digital Skills: Tutored Classes met 3 times in December in Wexford Library. Age Action Digital Learning also continued twice in December, 12 attended

WWETB Bunclody Further Education and Training Centre Visit. Students from WWETB Bunclody Further Education and Training Centre visited the library to learn how to use the printer, 6 attended.

Age Friendly Digital Literacy classes with the WWETB are conducted and tailored to each learner's pace, 19 attended in December.

New Ross Library held Festive Christmas Craft Workshop for Adults led by Therese from Seashore Explore, 10 attended. New Ross also held Macrame Angel Workshop with Zdenka 12 attended.

Energy Advice Clinic with the Community Energy Hub - New Ross Library

Members of the public with questions about making their home more energy efficient were invited for a one-on-one chat with an energy expert.

Age Friendly Wreath Making Workshop - Attendees at this workshop learned how to make a sustainable, traditionally handmade wreath, 10 attended.

ARCHIVES

Collections Management

In addition to 31 research enquiries via email, telephone and post, a total of 8 researchers visited the Archive during December. Research topics included the Bantry Commons court case and Wexford tenant rights (1820-35); references to Alma House, Wexford through the Nunn solicitors' collection (1920s-50s); Church of Ireland births, deaths and marriages in issues of the Wexford Conservative (1858-62); water services matters through WCC minutes, 1970s; examination of a collection of historic hurls from the former county museum collection; history of Martinstown House, Killinick.

Outreach

The extant registers, roll books and daily attendance registers (1873-2024) for Blackwater National School and its two predecessor schools, Killehard and Balyvaldon were deposited in the Archive in mid-December. Primary school archives – in particular, school registers – are an invaluable resource for family, social and educational history research.



Small Arts Festival and Failte Ireland Festival Open Call 2025

Wexford County Council Arts Office is pleased to announce 20 Festivals were awarded in the Festival Grant Scheme for festivals taking place in County Wexford during 2025 as part of the Arts office Small Arts Festival Grant and the Failte Ireland Small Festival Grant. The total fund is €45,000 and this supports festivals across the county with grants ranging from €1,500 - €3,000. Eleven festivals were awarded under the Small Arts Festivals strand nine festivals were awarded under the Failte Ireland strand.

The successful applicants under the Small Arts Festivals are: Askamore Arts Festival, FuddleFest, Jazz at Johnstown Festival, New Ross Guitar Festival, Spring Moves Dance Festival, The Gap Arts Festival 2025, The Gorey May Bush Féile 2025, One Voice Festival: Voices from Near and Far (title tbd), Write By The Sea, Community Short Plays Drama Festival, Tomhaggard and New Ross Piano Festival.

The successful applicants under the Failte Ireland Festival strand are: Wexford Uke Fest, Bring It Home Festival, New Ross, North Wexford Traditional Singing Féile, Rockin' Food & Fruit Festival, Rock n Roll Town Festival, The O'Neill Ancestral Trust, Tomhaggard Clean Coasts Festival, Duncormick Street Festival-A Wild Affair and Rosslare Harbour Festival 2025.

Westgate Heritage Centre Arts Space

Wexford Arts Centre has been contracted by the Arts Office to manage the day to day running of this space. The new Music Rehearsal Space at the back of the Heritage Centre will be open for bookings in January 2025. Heritage tours continue to access the space.

CULTURAL COMPANIONS RELAUNCH EVENT

Wexford Arts Office was delighted to host the Cultural Companions along with the Communities Department, Age Friendly Co-ordinator and Slainte Care on the 5th of December in County Hall. This event saw the relaunch of the network of adults of all ages interested in arts and culture who attend together as a group. The initiative was set up to help against social exclusion and loneliness throughout the County. For the launch, music group, the Session Sisters played, and dancer Hannah Scully performed. Poet, writer and playwright, Stephen James Smith also performed, and land artist Mayumi Nakabayashi did interactive work with the attendees. Over 50 people were in attendance.



ROOTS FOR THE FUTURE – CLIMATE ARTIST ASSEMBLY

Wexford Arts Office was awarded an Arts Council 'Invitation to collaboration' Research grant of €30,000 to research the development of a national Climate Arts Assembly for 2025/2026. The aim of this assembly is to understand, promote and pioneer methodologies within the arts and culture sector that are instrumental in shifting behaviour change around climate adaptation and mitigation.

This research is being led by an arts collective called 'Roots for the future' with 5 partner local authorities including Offaly, Clare, Cavan, Galway and Kilkenny. The research phase took place in 2024 and involved artists residencies in each county. The research findings from all the residences were presented in December to the Climate Action Team and creatives from Wexford in the Cow House Studios and then to the public in the Project Arts Centre, Dublin.

INTERNATIONAL RESIDENCY OPPORTUNITIES

Centre Culturel Irlandais Paris (CCI)

Wexford County Council Arts Office is delighted to be partnering again with CCI Paris in 2025 to support another fully funded artist residency for a Wexford based artist in Paris. Residencies of 1 to 3 months will be awarded for the period September 2025 - December 2026. This opportunity closes Tuesday 14 January 2025, 5pm. Open to artists across all artforms.

NATIONAL RESIDENCY AND FUNDING OPPORTUNITIES

ArtLinks Emerging and Professional Bursary Awards 2025

The ArtLinks partners of Carlow, Kilkenny, Waterford and Wexford local authorities' Professional and Emerging ArtLinks Bursary Awards 2025 opened in December 2024. These Awards are designed to support artists to develop their practice by providing artists with the time and resources to think, research, reflect and critically engage with their art. The art forms which ArtLinks support are Architecture, Circus, Dance, Film, Literature, Music, Opera, Street Arts, Theatre, Traditional Arts, Visual Arts.

Tyrone Guthrie Centre Residency Award

Two Wexford based artists to be selected in any art form to spend two weeks at the Tyrone Guthrie Centre at Annaghmakerrig, the artists' workplace in County Monaghan. Each bursary covers all board and lodging expenses for a one-week period, plus the use of a studio, depending on art form, and a stipend of €300 towards expenses. This opportunity opened for applications in late November and will close on the 28th January 2025.

Cow House Parenting Artist Residency Open Call

The Arts Office with Cow House Studios was pleased to offer a two-week residency designed specifically for parenting artists. The Parenting Artist Residency makes it possible for awarded artists to dedicate time to their work by offering childcare and supports during the residency.

Drama League of Ireland Scholarship 2025

Open call is for two scholarships for the Drama League of Ireland Residential Summer School which takes place at the University of Limerick from July 19th – 26th 2025. This opportunity is for professional and amateur theatre companies and/or groups. Deadline for application is the 28th January 2025.

MUSIC GENERATION

Music Generation is an ongoing partnership between Wexford County council, WWETB and Music Generation supporting performance music education countywide for young people in 25 schools and a variety of youth work contexts.

Christmas Album Launch, Wexford County Council

Musician Educator Aileen McCamley launched her Christmas album 'It feels Like Christmas'. She performed songs from the album on the day and was accompanied on the piano by Robert Scott, a renowned composer, vocal coach and musician based in London, who produced the album. The performance was introduced by Councillor Lisa McDonald and Music Generation Wexford's Music Development Officer Katherine Atkinson was also in attendance.

Christmas Concert Scoil Mhuire Rosslare

Musician Educators Aileen and Pete McCamley gave a special Christmas concert to the junior and senior classes of Rosslare National School with Robert Scott accompanying on piano. Aileen McCamley delivers the Music Generation programme in Rosslare and the concert allowed for the students to sing along to songs they had been rehearsing in the weeks prior and witness a performance led by professional musicians.

Coláiste an Átha Transition Year Workshops

Music Generation Wexford gave a series of workshops led by our Musician Educators Pete McCamley and John Colbert with the Transition Year students in Coláiste an Átha in Kilmuckridge. The workshops spanned a four-week period. The goal was to introduce music to young people who have never played before and foster their focus and engagement in music learning.

Scoil Mhuire Coolcotts Big Tesco Busk

The students of Scoil Mhuire Coolcotts gathered in Tesco for their annual 'Big Tesco Busk' performance in December. The performances were played on brass, wind and vocals and were led by Musician Educators Louise Malone and Jenna Larsen who deliver the Music Generation Wexford programme in Coolcotts.

CREATIVE PLACES ENNISCORTHY (CPE)

CPE is a 3-year Arts Council funded initiative in partnership with Wexford Arts Centre, Wexford Arts Office and Enniscorthy Municipal district seeking to embed creativity into Enniscorthy.

Fancy A Dance - Presentation Arts Centre - Open invitation to the public to join dancer Vivian Brody Hayes in two dance sessions in December This was a free event and had 20 participants.

The Arts Council of Ireland Visit to the Presentation - Presentation Arts Centre

Creative Places Enniscorthy hosted the All-Ireland Co-ordinators meeting for the Arts Council of Ireland. This was well attended and CPE had presentations from groups such as FDYS's young people on how Creative Places have impacted Enniscorthy.

Enniscorthy Men's Choir Performance - Presentation Arts Centre - Enniscorthy's first-ever male voice choir, under the guidance of Linda O'Rourke, gave their debut public performance in December. The group was joined by the St. Senan's Parish Choir, who provided additional support for the evening, there was a full house of up to 100 people in attendance for this event.

Enniscorthy Christmas Carol – A documentary - Enniscorthy Library - A screening of the short documentary 'Enniscorthy's Carol' by Aileen Lambert took place in December. The Documentary is available on Youtube and documents Aileen's work on tracing the background story and local connections to 'The Enniscorthy Christmas Carol' also known as 'The Wexford Carol'.

Songs From Our Town – Listening Party - Presentation Arts Centre - CPE hosted all 40 musicians who were involved with a community project of recording sessions that took place in the Orchard Recording Studios in Enniscorthy in Autumn of this year.

Yola Language Heritage Project




Creative Consultant for Festivals (developing neuro-affirmative access) Open Call



THE LOCAL INTEGRATION TEAM

Community Clinics

In December, the Local Authority Integration Team (LAIT) conducted twelve community clinics, providing vital support to individuals in the lead-up to Christmas.

Christmas Support Initiatives

The Insurance Risk Management team led a successful Christmas Jumper Day, raising funds through the generous contributions of Wexford County Council staff. These funds enabled LAIT to purchase and coordinate the donation of Christmas gifts for children in three IPAS centres. Additionally, Wexford Library donated children's books which were added to the gifts, promoting the love of reading and learning. This work ensured that every child living in an IPAS Centre in Wexford had a present this Christmas. A heartfelt thank you to everyone who contributed.

Interagency Collaboration

LAIT collaborated with Tusla on an art project for 17 children residing in one IPAS centre. Furthermore, the team supported Cruinniú na nÓg in hosting an art workshop specifically targeting 'seldom heard groups' of young people. This initiative was well-received by the team and the center, with valuable feedback expected to inform next year's planning.

The LAIT coordinated the Jesuit Refugee Service to deliver a information clinic in an IPAS Centre on the 10th December ensuring the residents are aware of their rights and entitlements.

International Refugee Protection Programme (IRPP)

The IRPP continues its close collaboration with two families who relocated to Wexford in 2024, working alongside other agencies to facilitate their integration. Preparations are underway for additional family relocations anticipated in January 2025, with services being coordinated to ensure a smooth transition.

The team also carried out an end of year review identifying the successes of the year and identifying plans for 2025.


