**3. Part XI of the Planning and Development Act 2000 (as amended) and Part 8 of the Planning and Development Regulations, 2001 (as amended):**

Mr. E. Taaffe outlined the broad detail of a discussion with the Members of Enniscorthy M.D. stating that the current proposed works will form part of a comprehensive URDF application. Mr. Taaffe advised that some additional parking spaces can be provided on the Murphy Flood site until such time as that site is being developed. Mr. Taaffe also confirmed that there will be investment in the Templeshannon area public realm, and a proposed regeneration project in the castle quarter.

There was a lengthy discussion with contributions from Cllr.'s A. Browne, J. Owens, C. Byrne, and P. Kavanagh.

3.1 LAC2312 – Revised street layouts and public realm improvements to Castle Hill, Castle Street, Church Street, Court Street, Weafer Street, Spout Lane, Cathedral Street, Main Street, Barrack Street and Island Road, Enniscorthy.

Having considered the report of the Chief Executive, on the proposal of Cllr. A. Browne, seconded by Cllr. J. Owens, the Council resolved to approve the Part 8 for revised street layouts and public realm improvements to Castle Hill, Castle Street, Church Street, Court Street, Weafer Street, Spout Lane, Cathedral Street, Main Street, Barrack Street and Island Road, Enniscorthy, in accordance with the terms of LAC2312, as circulated.

3.2 LAC2404 - Construction of 22 no. housing units, consisting of 8 no. 1-bed single storey adaptable units, 8 no. 3-bed two storey terrace units, 6 no. 2-bed two storey terrace units and associated site works at Cluain Fada, Morrisseyland, New Ross, Co. Wexford.

Having considered the report of the Chief Executive, on the proposal of Cllr. M. Sheehan, seconded by Cllr. J. Fleming, the Council resolved to approve the Part 8 for construction of 22 no. housing units, consisting of 8 no. 1-bed single storey adaptable units, 8 no. 3-bed two storey terrace units, 6 no. 2-bed two storey terrace units and associated site works at Cluain Fada, Morrisseyland, New Ross, Co. Wexford, in accordance with the terms of LAC2404, as circulated.

3.3 LAC2405 – St. Waleran's Proposed Sports Complex to include community sports building with indoor courts; outdoor cricket field, athletics track and hockey pitch; access arrangements including cycle paths, footpaths, 94 no. parking spaces, temporary access roadway, landscaping and ancillary site development works.

Having considered the report of the Chief Executive, on the proposal of Cllr. J. Sullivan, seconded by Cllr. F. Ó Súilleabháin, the Council resolved to approve the Part 8 for St. Waleran's Proposed Sports Complex to include community sports building with indoor courts; outdoor cricket field, athletics track and hockey pitch; access arrangements including cycle paths, footpaths, 94 no. parking spaces, temporary access roadway, landscaping and ancillary site development works, in accordance with the terms of LAC2405, as circulated.

**4. Submission on the Arklow Bank Wind Park 2 in Accordance With Section 291(4) of the Planning and Development Act 2000 (as amended) as a Coastal Authority**

Mr. E. Taaffe outlined that in accordance with Section 291(4) of the Planning and Development Act 2000 (as amended) Wexford County Council as a coastal planning

authority is a statutory consultee. Mr. E. Taaffe advised that as the period for public consultation ended on 12<sup>th</sup> August, Wexford County Council sought and were granted an extension of time from An Bord Pleanála to consult with the Members at the September Council meeting.

Mr. E. Taaffe gave the Members a summary of the key points contained in Wexford County Council's submission, which was circulated, and informed the Members that in accordance with Section 291(6) & (7), the Members can by resolution attach their own recommendation.

There was a lengthy discussion with contributions from Cllr.'s J. Codd, P. Barden, F. Ó Súilleabháin, G. Carthy, G. Lawlor, J. Sullivan, and M. Farrell. There was general positivity in relation to the need and benefit of renewable energy, whilst real concern was expressed in relation to the potential impact on the local fishing industry and those reliant on it for their livelihood.

The following motion was proposed by Cllr. Jim Codd, seconded by Cllr. Ger Carthy, and agreed by all to be included with Wexford County Council's submission to An Bord Pleanála:

"We call on An Bord Pleanála to establish the full impact of the construction and operation of the Arklow Bank Windfarm on the livelihood of our fishing industry and all those who benefit from it in the short, medium and long term."

## 5. Budget 2025

### a. Local Property Tax – local adjustment factor 2025 (LAF)

Ms. L. Lacey advised that the 2022 regulations establish the statutory deadline for passing a resolution to set a Local Adjustment Factor as follows:

- In the year in which a revaluation takes place this will be 31<sup>st</sup> August
- In every other year the deadline will revert to 15<sup>th</sup> October

Therefore, for the 2025 decision the deadline is 15<sup>th</sup> October, 2024

### b. Local Property Tax – provisional allocation 2025

Ms. L. Lacey informed the Members that while we have not received formal notification of the 2025 LPT allocation, we are assuming that the allocation for 2025 will remain the same as 2024 at €15,126,453 (excluding LAF) and including +15% LAF, as agreed as part of the Economic & Development programme commitments, at €16,985,613.

### c. Budget Meetings 2025 – prescribed periods

Ms. A. Byrne informed the Members that work is underway on drafting the Corporate Plan which must be adopted by the end of the year. Ms. Byrne advised that there will be a consultation process with the Members.

## 7. Appointment to Local Community Safety Partnership (LCSP)

Ms. C. Godkin informed the Members that seven appointments were being sought to the Local Community Safety Partnership (LCSP). Mr. M. Drea enquired if any Members intended forming a group in accordance with paragraph 18, schedule 10 of the Local Government Act 2001 for the purpose of making an appointment, with a minimum of five Members required to form a group.

**16. Notices of Motion**

16.1 Cllr. Tom Forde

"We ask that this council fly the Palestinian flag at Wexford County Council on the International Day of Solidarity with Palestine on 29th November."

On the proposal of Cllr. T. Forde, seconded by Cllr. G. Lawlor, the motion was carried.

16.2 Cllr. Aoife Rose O'Brien

"This council recognises the critical role of the school transport scheme in the lives of families and children and calls for immediate and comprehensive reform to provide a fit-for-purpose school transport scheme for all students requiring transport to their nearest school, irrespective of distance.

We ask that the Minister for Education and the Minister for Transport;

- ensure that families issued with concessionary tickets in the past continue to benefit from the service.

- ensure that the school transport scheme is reformed to serve the needs of students and their families adequately.

- ensure that adequate funding is allocated in the 2025 Budget to significantly expand school transport services so that it is a dependable service for students."

On the proposal of Cllr. A.R. O'Brien, seconded by Cllr. P. Breen, the motion was carried.

16.3 Cllr. John Fleming

"That Wexford County Council calls on the Minister of State at the Department of Housing, Local Government and Heritage with special responsibility for Local Government and Planning to change the regulation regarding a planning application site notice.

When a site is inspected and the site notice is not visible the applicant has to re-apply and go through the whole costly planning process again.

I am calling on the Minister to change the regulation to when the County Council inspect the site and find there is no planning documentation displayed they give a two week notice to the applicant to get the planning notice erected for inspection after that two week period."

On the proposal of Cllr. J. Fleming, seconded by Cllr. G. Laffan, the motion was carried.

16.4 Cllr. Fionntán Ó Súilleabháin

"Wexford County Council acknowledges the increased costs of construction-related work over recent times, and calls on the Department for Social Protection or other relevant agency to increase the Housing Adaptation Grants cap from 30K to 35K. as well as increasing the HOP and Mobility Aids Grant to take account of extra costs."

This motion wasn't moved as Cllr. F. Ó Súilleabháin was not present.

16.5 Cllr. Bridin Murphy

"That this Council would host a reception for all of the volunteers and organisers of Fleadh Cheoil 2024, thanking them in recognition of how Wexford has benefited from hosting this prestigious event".

On the proposal of Cllr. B. Murphy, seconded by Cllr. P. Breen, the motion was carried.

16.6 Cllr. Tom Forde

"Wexford County Council recognises the need for many households to move away from heating systems that have a complete reliance on a fire fuelled by coal and other fossil

fuels and also recognises that it can be difficult for many older people and those with specific medical issues to transport and use coal and other fuels. Currently, households cannot avail of the 'Housing Aid for Older People Grant' to upgrade their existing heating system from one which relies on the use of a back boiler system. We ask that the Minister update the criteria for these grants, to allow households to qualify, if their existing heating system relies on a fossil fuelled open fire so that they may upgrade their existing heating system."

Cllr. G. Laffan proposed the following amendment:

"Wexford County Council recognises the need for many households to move away from heating systems that have a complete reliance on a fire fuelled by coal and other fossil fuels and also recognises that it can be difficult for many older people and those with specific medical issues to transport and use coal and other fuels. 16.7 Cllr. Aoife Rose O'Brien

"This council recognises the critical role of mental health services and their accessibility and calls on the Minister of State with responsibility for mental health patients, for dedicated beds for patients experiencing crisis mental health to be allocated in Wexford that provide adequate, 24/7 care. "

On the proposal of Cllr. A.R. O'Brien, seconded by Cllr. T. Forde the motion was carried.

16.8 Cllr. Fiontán Ó Súilleabháin

"This council heartily commends all who contributed to the huge success of Fleadh Cheoil na hÉireann 2024. It notes the profits made by vintners and will engage with the Vintners Association to establish a Community Benefits Fund to assist a local mental health charity or other worthy local cause for Fleadh Cheoil 2025."

This motion wasn't moved as Cllr. F. Ó Súilleabháin was not present.

## **17. Any Other Business**

Cllr. T. Forde sought an update in relation to a motion which was submitted to the Minister in relation to funding for Talk to Tom.
