#### Traveller Group Housing

A scheme of two or more houses specifically built for members of the Traveller Community. Transitional Site

A transitional site provides basic facilities for families awaiting permanent accommodation.

#### Permanent Halting Site

A permanent halting site has individual bays with a full range of services provided in a small structure on each bay.

#### Temporary Halting Site

A temporary halting site has individual bays consisting of a yard with basic services.

#### Single Site

A house or site on its own grounds.

#### Transient Site

A transient halting site is a site providing basic facilities for short-term use by families pursuing a nomadic way of life or visiting relatives.

# **Section 1 – Introduction**

The Housing (Traveller Accommodation Act, 1998) requires Wexford County Council to prepare and adopt a 5- year Traveller Accommodation Programme to meet the existing and projected accommodation needs of members of the Travelling Community within its administrative area.

Directions for the preparation of a New Programme were issued on the 18<sup>th</sup> December 2023 by the Minister for Housing and Urban Development in Circular 46/2023 together with Guidelines for the preparation, adoption and implementation of Local Authority Traveller Accommodations Programme.

In accordance with Section 10 of the 1998 Act, the Minister has directed that the next Traveller Accommodation Programme will cover the period from the 1st January 2025 to the 31<sup>st</sup> December 2029. The Minister has specified that the latest date for the adoption of accommodation programmes is the 31<sup>st</sup> December 2024.

Wexford County Council will, as part of the Traveller Accommodation Programme 2025-2029, assess the current and projected accommodation needs for Traveller families in County Wexford over this period and outline specific proposals to ensure that this need is met. The programme will have regard to all relevant legislation.

Wexford County Council is committed to ongoing consultation with Travellers through the Local Traveller Accommodation Consultative Committee (LTACC).

The sixth Traveller Accommodation Programme 2025-2029 shall be reviewed no later than 30<sup>th</sup> June 2027. However, a review of this programme can be carried out at any time if considered necessary by Wexford County Council.

The existing TAP will continue to operate to end 2024 while Wexford County Council prepares for the adoption by end 2024 of the Sixth Traveller Accommodation Programme (TAP) 2025-2029. The Minister's objective is to ensure that the incoming elected members will have full ownership of the new TAP including implementation, which is also in line with the advice of the National Traveller Accommodation Consultative Committee (NTACC).

# **Section 2 – Policy Framework and Considerations**

The Traveller Accommodation Programme 2025-2029 has been prepared in accordance with the directions issued by the Minister for Housing and Urban Development in Circular 46/2023 and the guidelines for the preparation, adoption and implementation of TAP 2025-2029. It has also been prepared in accordance with the provisions set out in the Housing (Traveller Accommodation) Act, 1998 hereafter referred to as the 1998 Act. Wexford County Council is committed to the following as per Part II of the 1998 Act:-

- Assess the accommodation needs of Travellers (section 6).
- Prepare and adopt an accommodation programme by 31<sup>st</sup> December 2024 (section 7) for a 5-year period (2025-2029) and will provide for a range of accommodation to meet the identified needs (section 10).
- Section 16 deals with the steps necessary to implement the Traveller Accommodation Programme 2025-2029.
- The programme will be reviewed in each 3 year period or at such time as directed by the Minister (section 17). Wexford County Council shall review this programme no later than 30<sup>th</sup> June 2027.
- WCC shall appoint a Local Traveller Accommodation Consultative Committee (LTACC) (section 21) to advise on the provision and management of Traveller accommodation.

Part III of the Act deals with miscellaneous provisions including:-

- Power of the Chief Executive Officer to act in an emergency (section 24).
- Instigation of a caravan or site loan scheme (section 25).
- Amending planning legislation to require local authorities to account for Traveller accommodation in the County Development Plan (section 26 and 27).
- Provisions on anti-social behaviours to halting sites (section 34).
- Stronger powers for local authorities to deal with unauthorised temporary dwellings (section 35).

Wexford County Council commits to the ongoing review of the council's alignment of the TAP with NTRIS (National Traveller and Roma Inclusion Strategy II 2024 – 2028) and to new guidance issuing from the Department of Housing, Local Government and Heritage.

Wexford County Council Traveller Accommodation Programme 2025-2029

#### 2.1 Wexford County Development Plan 2022-2028

The Traveller Accommodation Programme 2025-2029 has been prepared with regard to the Housing Strategy contained within the Wexford County Development Plan 2022-2028. Implementation will be in accordance with the current County Development Plan and its successor.

Section 4.8.4 of the Wexford County Development Plan 2022 – 2028 details Wexford County Council's approach to Housing for Members of the Travelling Community which is supported by Objectives SH31 and Objective SH33. Section 5.2.24 of the County Housing Strategy provides the policy background for Wexford County Council's approach to the provision of specialist housing including Traveller accommodation, and this is supported by Objective PO11.

#### 2.2 Wexford Local Economic and Community Plan (LECP)

One of the high level goals in the Wexford Local Economic and Community Plan (LECP) 2023-2028 is:-

Goal 5: Wellbeing, inclusion, equality, and diversity will be at the heart of County Wexford's communities. Accessible spaces and amenities, and arts and cultural opportunities which support the development of community spirit and enhance the physical and mental well-being of residents will be provided. New arrivals will be embraced and integration promoted.

## 2.2.1 Traveller Interagency Group (TIG) - Wexford

Wexford Traveller Interagency Group works to ensure that the relevant statutory agencies and state supported initiatives involved in providing the full range of services to Travellers focus on improving the integrated practical delivery of such services.

Wexford Traveller Interagency is facilitated by the Community Development Section of Wexford County Council with the support of The Department of Justice, Equality and Law Reform. TIG members include representatives from the Traveller community and a wide variety of agencies, including; Ferns Diocesan Youth Service (FDYS), Tusla, Wexford County Childcare Committee, Waterford and Wexford Education and Training Board, Wexford County Council, Wexford Local Development, An Garda Síochána, The Probation Service, The Department of Social Protection, and the HSE.

#### Traveller Needs Analysis 2018 -

Wexford Traveller Interagency Group (TIG) adopted the <u>2018 Needs Analysis of</u> <u>the Traveller Community in County Wexford</u> on the 16 November 2018. The Needs Analysis provides an analysis of Travellers living in County Wexford, and their baseline needs. The analysis was carried out by highly respected social researcher, Mr Brian Harvey, under the aegis of the TIG, with the support of Wexford County Council. TIG members, agencies and local communities played a crucial role in accessing information and building relationships with Travellers across the county. The Traveller community had a pivotal role at all stages in this piece of research, from setting of the terms of reference through to presentation of the findings. This work was funded and supported by the Department of Justice, Equality & Law Reform and Wexford County Council. The information captured in relation to the Traveller Community in County Wexford will be used for service planning and future development of the WTIG in order to secure better outcomes for Travellers and improve the use of resources allocated across Government Departments for Traveller specific measures

# 2.3 Public Sector Duty

The Public Sector Equality and Human Rights Duty ('the Duty') is a statutory obligation for public bodies in Section 42 of the Irish Human Rights and Equality Commission Act 2014. Section 42(1) requires public bodies, in the performance of all their functions, to have regard to the need to eliminate discrimination, promote equality of opportunity, and protect human rights of staff, members, policy beneficiaries and people availing of their services. Section 42(2) requires public bodies to give effect to this Duty by undertaking an assessment of equality and human rights issues for the identified groups that are relevant to their functions, identify the plans, policies, and actions to address these issues, and to report annually on progress in this regard.

Wexford County Council has undertaken an assessment of equality and human rights issues for the identified groups relevant to all its functions and prepared an implementation plan for the ongoing implementation of the Duty. A cross-organisational working group is convened to drive and support this work and the ongoing implementation of the Duty. Implementation of the Duty with regard to the Traveller Accommodation Programme has involved: using the assessment of equality and human rights issues undertaken to establish those issues for Travellers that are of relevance to a Traveller Accommodation Programme; and completing a template to check that the draft programme had adequately and appropriately addressed these issues, introducing any changes found to be necessary on foot of this.

The ongoing implementation of the Duty will be a focus in the work of the LTACC which will receive annual reports on progress made in addressing the equality and human rights issues, and will be a focus in undertaking the mid-term review of the programme. It will, further, be a focus in the review and issuing of contacts to all organisations contracted by WCC to play roles that relate to Traveller accommodation. WCC staff working on housing issues will receive training on the Public Sector Equality and Human Rights Duty.

Wexford Local Authorities are committed to the reasonable accommodation of diversity in the provision of our services. Wexford Local Authorities create a culture of equal opportunity by avoiding the use of discriminatory language in all documentation and portray activities in a non-discriminatory way where pictures or other illustrations are used. There will be no express or implied discrimination against any customer at any stage. Staff will not make assumptions about the eligibility of individuals for certain services on grounds of gender, marital or family status, sexual orientation, religion, age, disability, race or membership of the Traveller community. All questions asked will be directed solely towards assessing the eligibility of customers for the service based on pre-determined criteria.

In terms of the implementation of the Public Sector Duty in the context of the Traveller Accommodation Programme 2025-2029 the following actions have been undertaken or are ongoing.

- In order to ensure that the application process for Social Housing Supports is understood by the Traveller Community, sessions will be carried out at local level for Traveller groups where the Area Housing Officers and Housing Liaison Officers will attend to explain the process and assist with any queries. This has already been offered through LTACC and at the next meeting these sessions will be finalised in terms of where, time that suits and what items that need to be included on the agenda.
- In terms of future proofing the programme to take into account the needs of members of Traveller families that will turn 18 over the period of the programme and may need their own accommodation, a provision for this was made – see Section 8.
- Housing staff have recently undertaken anti-racism training and Public Sector Duty training is planned for staff and also we be offered to members of LTACC.

## 2.4 IHREC Equality Review Process

Wexford County Council is cognisant of the recommendations of the Irish Human Rights and Equality Commission Equality Review. WCC is committed to working with members of LTACC and relevant agencies in progressing the recommendations outlined by the IHREC. Work has been undertaken in this area in preparation of this Programme and is ongoing.

#### **Consideration of Cultural Needs of Travellers**

Wexford County Council continue to develop culturally specific responses to the housing needs of Travellers. The Council recognises that there are very real barriers that have been built over a long period of time in relation to building trust with the Traveller community.

# **2.5 Equality Legislation**

Wexford Local Authorities are committed to ensuring full compliance with the provisions of the Equal Status Acts. As such, there will be no express or implied discrimination or harassment against any customer at any stage. Staff will not make assumptions about the eligibility of individuals for certain services on grounds of gender, marital or family status, sexual orientation, religion, age, disability, race or membership of the Traveller community. All questions asked will be directed solely towards assessing the eligibility of customers for the service based on pre-determined criteria. Systemic issues that might disadvantage Travellers are kept under review and addressed where and when identified. A culture of equal opportunity is sustained by avoiding the use of discriminatory or stereotypical language in all documentation and portray activities in a non-discriminatory way where pictures or other illustrations are used.

## 2.6 Integration

WCC supports an intercultural integration in communities that include Travellers and in communities where Traveller specific accommodation is located, based on principles of equality, cultural diversity. WCC will explore and develop approaches to intercultural integration, taking steps to promote positive intercultural interactions, and to enable intercultural competence and collective identity within these communities.

# Section 3 – Policy Statement

It is the policy of Wexford County Council to provide accommodation appropriate to the needs of Traveller households who are approved applicants for accommodation by Wexford County Council. These are included in the assessment of need in the preparation of this Programme. The overall aim of Wexford County Council.is to enable every household to have available to them an affordable dwelling of good quality, and as far as possible at a tenure of their choice. Wexford County Council recognises Travellers' identity as a minority ethnic group and endeavours to provide accommodation suitable to their specific needs.

Housing options such as group and standard housing (including one off houses) as well as halting sites and temporary/emergency sites are provided in recognition of Travellers' cultural identity as a minority group.

Wexford County Council is committed to addressing the accommodation needs of housing applicants throughout the county. There are dedicated housing teams throughout the county comprising of a social worker, housing liaison officer and an area housing officer. One of the social workers sits on LTACC in an advisory capacity and has a specific remit in terms of Traveller Accommodation. Wexford County Council has a contract with Focus Ireland to provide a Tenancy Sustainment Service for individuals and families. This service is available to assist them accessing and maintaining either private rented, local authority accommodation or accommodation provided by the Approved Housing Bodies.

## **3.1 Anti-Social Behaviour**

In the interests of good estate management, Wexford County Council will have due regard to its Anti-Social Behaviour Strategy 2018-2024.

If a tenant is evicted from Wexford County Council accommodation due to anti-social behaviour they will be deemed to have rendered themselves homeless and may not be provided with another home by the council. They will not be considered for another allocation for a probationary period of 3 years or until such time that WCC is satisfied that

the evicted tenant is capable of living and agreeable to live in the community, without causing further anti-social behaviour.

#### 3.2 Traveller Specific Accommodation

Recognising Travellers' distinct culture and needs, Wexford County Council has provided Traveller specific accommodation consisting of halting sites and Traveller group schemes. It is the policy and practice of Wexford County Council to provide Traveller specific accommodation in accordance with the assessment of need and subject to feasibility.

#### **3.3 Unauthorised Encampments**

The incidence of roadside or unauthorised encampments is relatively infrequent in Wexford. They present difficulties in relation to health and safety and can be hazardous to road users. Wexford County Council engage with unauthorised encampments on an individual basis.


# **Section 4 – County Profile – Statistics**

Wexford has a population of 163,919 recorded in Census 2022. This has increased by 9% since the Census in 2016.

The number of Irish Travellers living in the State and counted in Census 2022 was 32,949; an increase of 6% from 30,987 in the 2016. This shows that in Census 2022, 6.5 out of 1,000 total population in the State were Irish Travellers.

According to the 2022 Census, County Wexford has a higher than national rate of Travellers. The rate of Irish Travellers in Wexford is 8<sup>th</sup> highest in the state at 8.9 per 1,000 with the national rate at 6.5.

A total of 1,441 Travellers were recorded as living in the County which is a decrease of 4% on the 2016 Census figure (1,508).



The highest concentrations of Travellers live in the areas of Bunclody, Clonroche, Enniscorthy, Taghmon, New Ross and surrounding areas.

# 5.1 2024 Assessment of Need

An assessment of housing need was carried out as per Department of Housing, Planning and Local Government guidelines (DHPLG) by the Area Housing Officers in May 2024 to establish the existing and projected accommodation needs of the Traveller community in County Wexford who have applied for Social Housing Supports. This process involved assessing each Traveller applicant who qualified for Social Housing Supports in each municipal district to determine the overall need.

Seventy one Traveller family applicants were identified through this process and the following table gives a breakdown of their accommodation requirements:-

Families can only be included in the assessment of need and therefore considered for accommodation if the appropriate application forms are completed and submitted to WCC.

Once submitted the AHO will assess them to determine the accommodation need in accordance with the statutory assessment regulations.

Families will be supported in this process and the onus to complete and submit the appropriate forms is on the applicants themselves.

It should be noted that there are a number of families living in social housing tenancies where the applicants consider that their current accommodation no longer meets their needs. They have applied for housing transfers to more suitable accommodation. These families will have their ongoing accommodation needs addressed as part of Wexford County Council's housing allocation and will be considered as part of the overall assessment of accommodation need.

## **5.2 Current Profile in Co Wexford**

In December 2023 as part of the annual National Traveller Estimate a total of 759 families were identified in County Wexford. Six hundred and sixty-seven are currently accommodated and 92 families are without accommodation. The table below shows the breakdown by municipal districts.



## 5.3 Analysis of Annual Traveller Estimate

The graph below shows the results of the Annual Traveller Estimate from 2019-2023. From the Estimate of Traveller families it is noted that there is an decrease of 1.31% from 2022 to 2023. A total 759 families were identified in 2023 as residing in County Wexford and of the total, 667 are categorised as with accommodation. This is an increase from the start of the previous programme in 2019 of 8.2%. Throughout the programme we have seen year on year apart from 2021 an increase in the number of families with accommodation.



# Section 6- Role of Wexford County Council

Wexford County Council has a responsibility for meeting the accommodation needs of the Traveller Community through the adoption and implementation of the Traveller Accommodation Programme 2025-2029. All housing applications will be considered in accordance with the Housing Allocation Scheme and Scheme of Letting Priorities. Applications must be made by means of the standard social housing application form. Advice and assistance will be provided to applicants and/or their representative, if requested by the applicant, to address any difficulties that may arise in completing the application form.

## **6.1 Accommodation Types**

The Council will promote a range of and enable access to social housing options for Traveller families which are set out hereunder:-

- Standard Local Authority Housing
- Traveller Group Housing
- Halting Site
- Specially Adapted Housing
- Transient Sites
- Mobility Aids Housing Grant Scheme
- Housing Aid for Older People
- Housing Adaptation Grant for People with a Disability
- Long Term Leasing
- Voluntary or Co-Operative Housing
- Rental Accommodation Scheme (RAS)
- Housing Assistance Payment (HAP)

## **6.2 Consultation**

The Housing (Traveller Accommodation) Act, 1998 requires that an extensive consultation process underpins the preparation and implementation of the Traveller Accommodation Programme. All Traveller Accommodation Programmes are required to be prepared in consultation with other adjoining local authorities, Health Service Executive, local Traveller

organisation and groups, individual Travellers, the local LTACC and other relevant community groups and the public in general.

As part of the consultation process Wexford County Council wrote to the following stakeholders on 18<sup>th</sup> January 2024 giving notice of the intention to carry out the Assessment of Need and inviting submissions for the preparation of the draft TAP 2025-2029 as per Section 8 of the Housing (Traveller Accommodation) Act, 1998.

Five submissions were received, and these were noted and considered in preparation of the draft Programme -see Appendix 1.

Once the draft programme was prepared and brought to LTACC and full Council on 1<sup>st</sup> July 2024 it was agreed to proceed to full public consultation. An advertisement was placed in the newspaper on the 10<sup>th</sup> July 2024 and the consultation process was open until the 20<sup>th</sup> September 2024. Two further submissions were received during this period which are also include in Appendix 1. All submissions have been responded to by management and none necessitate a change in the programme at hand.

## 6.2.1 Local Traveller Accommodation Consultative Committee (LTACC)

The Wexford LTACC has 12 members which includes elected members and Traveller representatives. The committee gives advice on the provision and management of accommodation for Travellers under Section 21 of the Traveller Accommodation Act, 1998. Membership of the LTACC provides for 5 Traveller positions, Elected Members of the Council and council staff. The committee aims to meet on a quarterly basis.

The Committee is chaired by the Chairman of Wexford County Council. WCC has appointed the following elected members to LTACC at their Annual General Meeting on the 21<sup>st</sup> June 2024:-Cathaoirleach of Wexford County Council (ex oficio) – Cllr Pip Breen Chair of the Housing and Community SPC (ex oficio) – Cllr Jim Codd Cllr Tom Forde Cllr Lisa McDonald Cllr Aoife Rose O' Brien Cllr George Lawlor Members representatives from the Traveller Community are elected through the Wexford Public Participation Network (PPN).

The LTACC will, further, give advice on equality and human rights issues and on accommodating cultural diversity, and play a role in the ongoing implementation of the Public Sector Equality and Human Rights Duty in the context of TAP. Training will be provided on an ongoing basis to the LTACC and its members to ensure effective participation by all, create a working environment of mutual respect, and enable shared cultural competence.

# 6.2.2 Wexford Public Participation Network (PPN)

The PPN is a network of Community and Voluntary groups, clubs and organisations working at local level throughout County Wexford. Wexford PPN is involved in informing, developing and representing its member groups and is the structure through which the community voice and local expertise can be fed into a number of local decision making bodies. Public Participation Networks came into effect with the Local Government Reform Act 2014 – Section 46.

# 6.3 Housing Teams

County Wexford has dedicated housing teams consisting of an Area Housing Officer, Housing Liaison Officer and Social Worker. This team assists in the development of housing strategies, including homelessness, disability and anti-social behaviour, accommodation advice and allocation services within County Wexford. They work in partnership with other agencies to secure the best housing outcomes for people at risk of or experiencing homelessness.

## 6.3.1 Area Housing Officer (AHO)

The Area Housing Officers assess clients for Social Housing Supports in County Wexford. They nominate clients for vacancies in their areas of choice. They create and maintain files and records of service users, ensuring that information is recorded in iHouse in a timely and accurate manner. They service a weekly housing clinic whereby clients can make appointments to see the AHO who can provide information and assistance to them on a range of housing issues. The AHO also works with Residents Associations within WCC estates. They also undertake residential housing inspections. In conjunction with the social workers they allocate emergency accommodation as appropriate.

## 6.3.2 Choice Based Letting

Choice Based Letting was introduced in Wexford County Council in 2023. This was a new system of allocating properties which allows applicants to have more choice in terms of the type of accommodation and location where they prefer to live. This has reduced the level of refusal for offers of social housing significantly. The introduction of Choice Based Letting has had a significant impact on the rate of refusal across all types of accommodation offers. Again, in order to ensure that the introduction of this new system of allocations did not affect the level of accessibility to this process by Traveller families, an information / training session on the system / process was offered at LTACC. Although no specific session has been held for the Traveller community which can be arranged at any stage, advocates for specific groups of clients including travellers have been offered and attended these sessions. The particular barriers experienced by Travellers with regard to the housing allocation system will be a subject for review and consideration with a view to developing initiatives that might be effective in addressing any such barriers.

# 6.3.3 Traveller Identifier

Applicants for social housing supports can identify as 'Traveller' on the Social Housing Supports application form (National form). Steps will be taken, in conjunction with Traveller organisations, to build an understanding of this option among Travellers, ensure an appreciation of its potential to establish and improve with accuracy the situation of Travellers.

# 6.3.4 Information Provision Targeted on Traveller Community

In order to ensure that the application process for Social Housing Supports is understood by the Traveller Community, sessions will be carried out at local level for Traveller groups where the Area Housing Officers and Housing Liaison Officers will attend to explain the process and assist with any queries. This has already been offered through LTACC and at the next meeting these sessions will be finalised in terms of where, time that suits and what items that need to be included on the agenda.

## 6.3.5 Housing Liaison Officer (HLO)

The Housing Liaison Officers carry out pre-tenancy meetings for all new tenants. They establish contact and liaise with all tenants of WCC throughout the county. They foster good working relationships between local communities and WCC. They liaise with other agencies to prevent anti-social behaviour and promote good estate management. They work closely with the Social Workers and Area Housing Officers. They also undertake residential housing inspections on both WCC housing and on private rented houses. They record and investigate complaints including breaches of tenancies and anti-social behaviour. They serve warning letters and statutory notices when required. They attend court to give evidence.

## 6.3.6 Social Worker

Local Authority Social Workers uphold the principles of CORU's Code of Professional Conduct and Ethics for Social Workers and provide a professional social work service to Housing Department service users. This service ranges from providing housing advice and information to the provision of targeted social work intervention and support. They also carry out assessments with a view to making recommendations to the Housing Department that facilitates the matching of resources to the needs of service users, identifying and addressing service users' needs and supporting social inclusion and community development.

The social worker also engages in both case and project based inter-agency work, providing a link between local authorities and external agencies.

They also participate in the development of policies. Some other issues that a social worker can assist with include mental health issues, domestic violence, child protection and financial issues.

Within the Social Work Team, there is one Social Worker who attends LTACC in an advisory capacity who is assigned specifically to advise on Traveller Accommodation related projects with a focus on the social and cultural needs of Travellers.

#### 6.3.7 Pre-tenancy meetings

The Housing Liaison Officers (HLO) conduct pre-tenancy meetings prior to the allocation of all types of accommodation units. These courses are very informative and assist in the prevention of anti-social behaviour and breaches of tenancy agreements. The course examines the Tenancy Agreement and explains the consequences of breaching the terms of same. The obligations of tenants (e.g. payment of weekly rent, maintenance of dwellings etc) are outlined. The HLO issues the new tenant with tenant and maintenance handbooks which outlines what services WCC offer, how to access them and the tenant's role.

#### 6.3.8 Tenant Participation and Estate Management

Wexford County Council encourages tenant participation in the management and maintenance of Traveller specific accommodation, social housing or in private rented properties. The Area Housing Officers meet various residents associations on site and provide funding for equipment for the upkeep of estates.

A model of culturally appropriate estate management will be explored and developed in relation to Traveller specific accommodation. This will build on the work done with the WLD Traveller Health Programme in the previous TAP. Barriers to Traveller tenant participation in social housing estates will be examined and efforts made to encourage participation.

#### 6.3.9 Emergency Accommodation

In the event of an emergency or family crisis Wexford County Council may provide appropriate emergency accommodation on a short term basis to meet the needs of the individual or family concerned. In addition, WCC offer a HAP Place Finder service which will support homeless persons in Wexford to find a private rented tenancy using HAP. An integrated Homeless Service Centre (HSSU) was opened in Wexford in 2019. The centre offers homeless supports, advice and services in one location, with an emphasis on homeless prevention and supports. This is a collaborative initiative by Wexford County Council working in partnership with the HSE and Focus Ireland. Some of the main services are being provided through the HSSU working in partnership with external state agencies and NGO's

Steps will be taken to support and ensure cultural competency across these providers and roles, to establish culturally specific needs of Travellers experiencing or at risk of homelessness, and to identify and develop approaches to accommodate cultural diversity within homelessness services.

A Homeless Co-ordinator role was created in Wexford County Council in 2019 to manage the homeless teams and report on homelessness levels. This team includes social care workers who provide support to clients experiencing homelessness or at risk of homelessness and also a social worker who provides assistance in cases involving Traveller families.

# 6.3.10 Building relationships of Trust

McDonagh (2018) found that Travellers often had a mistrust in services and were concerned about the lack cultural knowledge within services. Wexford County Council are committed to breaking down these barriers by continuing to engage with Traveller families, by listening to Traveller Representative and by working with Traveller specific supports in the community.

## 6.4 Maintenance

Wexford County Council has a responsibility for the management and maintenance of all types of local authority accommodation units in partnership with the tenants to achieve an excellent two-way working relationship. The aim of this is to supply these services effectively. Tenant and maintenance handbooks are issued to all tenants which outlines what services are offered, how to access them and the tenant's role. They aim to provide

the tenant with a user friendly manual on what services are offered by the Housing Department and how the tenant can access them

\*\*As part of the Caravan Loan Scheme a number of new or replacement mobile homes were located at sites across the county. At Marshmeadows site in New Ross a complete clean up of the site was carried out as part of this, this explains the higher spend to date in 2024.

#### 6.4.1 Fire Safety

It is the policy of Wexford County Council to maintain appropriate fire safety standards at all local authority housing units which includes Traveller specific accommodation. It is recognised that fire safety is a shared responsibility of both WCC and its tenants. Wexford County Council will continue with the following programmes initiated in 2016:-

- Ensure all accommodation units are fitted with working smoke alarms.
- Ensure accommodation on halting sites are maintained to a standard to prevent fire spread between units.
- Ensure fire hazards on halting sites are monitored and reduced to a minimum.
- Ensure pre-incident planning visits are carried out for required sites by the fire service.
- Continue with a process of engagement with the Traveller community through the various groups to promote improved awareness on fire safety issues.
- Continue with the guidance as set out in the recommendations contained in the National Directorate Fire and Emergency Management "Report on Review of Fire

Safety in Local Authority Provided Traveller Accommodation" published September 2016.

#### 6.4.2 Fire Safety output

- All accommodation is periodically checked for working smoke alarms in conjunction with response maintenance calls and augmented as necessary.
- A detailed program of annual inspection of all Traveler accommodation properties is underway to ensure that they have working Smoke & CO alarms and fire blankets fitted.
- Sites are monitored and accumulation of flammable material are removed as necessary.

# Section 7 - Review of Traveller Accommodation Programme 2019-2024

The existing programme *(Wexford Local Authorities Traveller Accommodation Programme 2019-2024)* which took effect on 8<sup>th</sup> July 2019 will continue to operate until the end of 2024.

The Minister's objective in terms of the extended time period is to ensure that the incoming elected members will have full ownership of the new TAP including implementation, which is in line with the National Traveller Accommodation Consultative Committee advice.

A mid-term review was carried out of the 2019-2024 Programme in 2022. As part of this review an assessment of housing need was carried out in August 2022 which identified families in need of accommodation. This statutory assessment of need assessed all applicants seeking assistance with accommodation. The number of approved Traveller families seeking accommodation at this time was 73 families. To take into account this revised assessment of need estimate, the target figures for the final two years of the programme were increased by 26.

# 7.1 Progress Achieved to date - TAP 2019-2024

Wexford County Council has assisted Traveller families to find suitable accommodation over the period of the 2019-2024 programme. WCC has endeavoured to meet the targets set out in the Traveller Accommodation Programme 2019-2024; the table below shows the accommodation units offered over the lifetime of the programme.

Although at this point in time we are 17 units under target as the programme will continue until year end we estimate that at least a further 6 units will be allocated to Traveller families by then. It should also be noted we increased the targets in 2022 following the mid-term review and we have surpassed the 100 units the target under the original adopted programme.

\* It is expected that at least 6 more units of accommodation will be offered to traveller families by the end of 2024 thereby increasing the delivery to 115.

In terms of 109 accommodation offers made only 11 were Traveller Specific Accommodation. Therefore the other 98 were funded through the Social Housing Programme and were not eligible specific funding under Traveller Accommodation.

It is also worth noting that all offers of accommodation were not accepted for various reasons.

## 7.2 Housing Output

During the period of the 2019-2024 programme, 52 families were housed in local authority built houses / turnkey developments, 4 were housed in Traveller specific houses, 34 were housed by Approved Housing Bodies, 12 families were supported through HAP (Housing Assistance Payment) and 7 at sites.

## 7.3 Specific Traveller Accommodation Units

The following Traveller Accommodation Units were delivered during the lifetime of the Traveller Accommodation programme 2019-2024:

\* A further proposal for a house in the New Ross Municipal District is progressing and at this time has been submitted to the Department for approval.

## 7.4 Pilot Caravan Loan Scheme

This scheme which operated throughout 2023 and until the end of March 2024 was promoted through LTACC and through our social workers. We issued 13 applications to interested families and received 8 applications.

Wexford County Council was initially allocated 4 loans under the scheme, however, this was increased to 5 due to a request for an increase to match the number of eligible applications received.

This Scheme proved very successful and if there is further interest in same it may be run again.

The mobiles that were funded under this scheme were at Marshmedow's site, New Ross and Bunclody.

# 7.5 Group Housing Scheme Progress

The need for a Group Housing Scheme was identified in the 2019-2024 Programme and progress on this project has been made.

The following steps have been completed to date:

- Cena (Culturally Appropriate Homes Limited) an Approved Housing Body that is working for and with Travellers to address critical accommodation needs, were engaged to do a feasibility study with the families who requested the Group Housing Scheme to ensure that what Wexford County Council is designing will meet their accommodation needs including any cultural specific requirements of the families.
- The elected members in the relevant Municipal District have been consulted with on several occasions and a facilitator was engaged to carry out workshops with them around the plans for a Group Housing Scheme in their Municipal District. This proved very positive.
- At this point the scheme is being designed by Wexford County Council informed by the report of CENA following engagement with families. This will hopefully result in a design which is deliverable whilst taking into account the family's needs (including cultural specific around accommodation). Due to the nature of the preferred site there is a requirement under the Planning and Development Act to submit the application directly to An Bord Pleanala which is the next stage once design is finalised following further consultation with the families.

## 7.6 Improvement Works at Marshmeadow's Site

CENA was engaged following a request for quotation process to carry out a facilitation piece with the residents at the site.

The key objective of this piece of work is to provide training and support to assist the residents at the site in tenancy sustainment and development of their community to ensure that a positive environment is maintained at the site. Initial engagement with the family has taken place and this project is ongoing.

A request for feedback at LTACC in terms of what the residents at the site themselves wanted was made which was used to inform the facilitation process.

Items Raised included:

- Painting of Bays
- Replacement of Floor Covering
- Play Area for Children
- Gate at Entrance
- Community Building back to original use
- Fire Assembly Point identification
- Control of Vermin
- General improvement of Hand Ball Alley.

Coupled with the facilitation work, the caravan loan scheme resulted in 4 new / replacement mobiles homes at the site. Wexford County Council's maintenance team lead by the Senior Executive Engineer in Housing whilst assisting with the removal of old mobiles, carried out a very large clean up of the site. Some of the works above identified by the residents were carried out as part of this process or are being considered as part of a planned maintenance programme for the site where appropriate. Wexford County Council are continuing a programme to return the community building to its former use. Work to date includes, removing horses, cleaning out and securing the building, repairs to the roof. Internal works include provision of toilets and kitchen.

The next stage here is to continue the engagement with the residents to ensure that the newly refurbished site maintains this positive environment and put supports or linkages in place with relevant staff or other agencies to ensure this occurs.

#### 7.7 Other Projects

- Wexford Council Council have undertaken work in collaboration with the WLD Traveller Community Health Programme and residents from Bunclody Site. The residents have now formed a committee to work collectively and to advocate on behalf of Site residents, with the view to addressing issues relating to health, fire safety and other wider social and economic factors using a solution focused approach. This committee is supported by WLD via SICAP and the Traveller Community Health Programme in terms of networking, empowerment and building capacity.
- The Traveller Inclusion Project managed by FDYS aims to work with the Traveller communities throughout County Wexford to build Traveller capacity by providing support, information and referrals through culturally appropriate needs-based services and programmes. The community house at Drumgoold Group Housing Scheme houses the TIP service for this area and this location within the community adds to the success of the project.

# Section 8– Traveller Accommodation Programme 2025-2029

Wexford County Council will endeavour to meet the accommodation needs of Travellers who are approved housing applicants within the 5-year period of the Traveller Accommodation Programme 2025-2029. The dedicated housing teams active throughout the county are complimented by a Homeless HAP Place Finder worker to assist in sourcing private rented accommodation. Together they provide an integrated approach to addressing the accommodation needs of the Traveller Community. While the targets reflect the preferred options, WCC will work with applicants to explore all options of meeting their accommodation needs either in a temporary or permanent basis.


## 8.1 Analysis of Assessment of Need

An assessment of housing need was carried out as per Department of Housing, Planning and Local Government guidelines (DHPLG) by the Area Housing Officers in May 2024 to establish the existing and projected accommodation needs of the Traveller community in County Wexford. This process involved assessing each Traveller applicant who qualifies for Social Housing Supports in each municipal district to determine the overall need.

Seventy One Traveller family applicants were identified through this process and the following table gives a breakdown of their accommodation requirements:-

While Traveller specific accommodation will be provided where possible, the main source of accommodation units over the lifetime of this programme will be standard social housing in its current context, which includes RAS, Leased Accommodation, Approved Housing Bodies and also supported Private Rented Accommodation.

Families can only be included in the assessment of need and therefore considered for accommodation if the appropriate application forms are completed and submitted to WCC. Once submitted the AHO will assess them to determine the accommodation need in accordance with the statutory assessment regulations. Families will be supported in this process and the onus to complete and submit the appropriate forms is on the applicants themselves.

It should be noted that there are a number of families living in social housing tenancies where the applicants consider that their current accommodation no longer meets their needs. They have applied for housing transfers to more suitable accommodation. These families will have their ongoing accommodation needs addressed as part of Wexford County Council's housing allocation and will be considered as part of the overall assessment of accommodation need.

The assessment of need identified that 14 families require ground floor accommodation / special needs accommodations. A group has been established in the Housing Section to monitor and review applications where specially adapted housing is needed to ensure a delivery stream is identified early on. This includes staff from Capital delivery, Allocations, Housing representative on the Housing Disability Steering Group and Senior Executive Officer.

# 8.2 Projected Accommodation Needs 2025-2029

In additional to the analysis of assessment of need, consideration has also been given to the projected need for accommodation during the period of this Programme 2025-2029. The 2022 Census indicated an decrease of 4% on the 2016 Census figure of the number of Traveller Families in County Wexford. The annual Traveller count in December 2023 shows a decrease of 38.5% between 2022 and 2023 of the number of traveller families without accommodation.



The assessment of need identified 71 families and although there was a decrease shown both in the census figures and in the annual estimate in terms of families who are in need of accommodation, the overall population of the county increased by 9% from 2016-2022. Therefore it would be prudent to factor in potential growth in terms of the assessment of need at 5% or 3 additional units.

According to the recent CSO 2022 figures the Age Profile of County Wexford Traveller Population is as follows:

To ensure the programme is future proofed in terms of potential new Social Housing Applicants that may apply due to turning 18 during the lifetime of the programme, an analysis of these potential applicants was carried out as part of the assessment of needs.

The analysis carried out by the Area Housing Officers identified 73 children of applicants or occupants of tenancies that are currently 16-18 years old. Not all of these children will require housing in this period as they may find their own; form their own family units or move out of the county. However, to take this cohort into account a provision for 30% of this will be included in the target figures to take this into account which is 22 additional units needed. It is proposed that during the mid-term review we will carry out a similar exercise for those children of applicants and occupants who at this point are between 14-16 years old.

# **8.3 Annual Targets**

In order for Wexford County Council to meet the projected accommodation need during the lifetime of this programme, it is considered that the best option is to spread the targets evenly over the 5-year period.

The Council will build, purchase and liaise with Approved Housing Bodies and the Private Sector to meet the accommodation need of families whose preferred choice is standard social housing. The projected need taking into account the assessment of needs carried out in May 2024 (71), projected population growth (4% or 3 units) and future proofing exercise carried out to identify children turning 18 during the first half of the programme (22) is 96 units.

As part of the assessment of need it was noted that only 7 families expressed an interest in Traveller Specific Accommodation. As this only represents 7% of accommodation needs, the remaining 93% of the Councils Traveller Accommodation provision is not eligible for specific funding.

## 8.4 Implementation Strategy

The assessment of need and projected growth indicates a need to provide 96 units of accommodation during the lifetime of this programme. While the targets reflect the preferred options, WCC will work with applicants to explore all housing options with a view to meeting their housing need. It is acknowledged that true preferences are difficult to ascertain in contexts of shortages of all forms of accommodation, and WCC will explore and develop further means of engaging with Traveller families and Traveller organisations to review and assess data on true preferences in relation to accommodation needs. The

LTACC will advise on and keep such approaches under review and links on this issue could be explored with CENA. The Council will avail of the full range of housing options through the following methods:-

## 8.4.1 Private Rented

The Long Term Leasing Scheme, Rental Accommodation Scheme (RAS) and the Housing Assistance Payment (HAP), will be utilised as a means of addressing long term housing needs. It is acknowledged that there are issues arising in relation to the availability of private rented accommodation. The Homeless HAP Place Finder will assist Traveller families with the threat of becoming homeless in sourcing suitable private rented accommodation.

## 8.4.2 Standard Social Housing

Standard Local Authority accommodation remains the preferred accommodation option for households in Wexford. It is envisaged that the need will be met through the housing construction programme. As casual vacancies become available WCC will strive to accommodate families according to need.

## 8.4.3 Traveller Group Housing

Four families expressed an interest in Traveller Group Housing in the Wexford Municipal District Area during the assessment of need. At present Wexford County Council has 7 group housing schemes throughout the county in the following locations:-

Steps will be taken to examine and implement approaches to retrofitting existing Traveller specific accommodation, and ensuring energy efficiency in new Traveller specific accommodation. Current and future provision kept under review to ensure quality of this provision and its capacity to meet the cultural needs of those living there

# 8.4.4 Approved Housing Bodies (AHB)

Wexford County Council supports housing delivery of units by Approved Housing Bodies and during the 2019-2024 TAP, fourteen traveller families were housed through this delivery stream.

Steps will be taken to support and ensure cultural competency within AHBs and to compliance with the Public Sector Equality and Human Rights Duty passed on in an appropriate form.

# 8.4.5 Reasonable accommodation of Cultural Diversity

Wexford County Council is committed to the reasonable accommodation of cultural diversity in the provision of our services and will continue to develop culturally specific responses to the housing needs of Travellers. This extends to consideration of and action on:

- Provision of Traveller specific accommodation, with attention to design that is culturally appropriate, wherein new guidance being developed at national level will be implemented.
- Anti-Racism and cultural competence training for staff.

## 8.4.6 Caravan Loan Scheme

WCC will seek and support applications from interested Traveller families in relation to the new preferential National Caravan Loan Scheme for Travellers.

## 8.5 Review of TAP 2025-2029

Wexford County Council shall review the Traveller Accommodation Programme 2025-2029 no later than 30<sup>th</sup> June 2027. However, a review of this programme can be carried out at any time if considered necessary by WCC. Revised targets, if necessary, will be set for the following years based on the outcome of the review.

Steps to meet the Public Sector Equality and Human Rights Duty will be reviewed as part of the Mid-Term Review in accordance with the WCC Implementation Plan for the Duty.

## 8.6 Funding

The capital provision for Traveller specific accommodation identified in TAP 2025-2029 will be sourced from the Department of Housing, Planning and Local Government (DHPLG) under the Annual Capital Funding Allocation for Traveller Specific Accommodation. Wexford County Council will submit proposals to:-

- Progress Traveller Accommodation projects already approved.
- Submit further details of Traveller Accommodation projects approved in principle.
- Submit new projects for Traveller Accommodation for consideration as they arise.

Housing acquisitions will be submitted to the DHPLG under the Social Housing Capital Investment Programme (SHCIP) and the Capital Assistance Scheme (CAS) as with all social housing acquisitions.

## 8.7 Traveller Organisations

WCC acknowledges the value and importance of well-resourced Traveller organisations with a capacity to organise within their community and bring forward the collective voice of their community. WCC seeks to enable and engage with effective Traveller organisations and their participation in making progress on providing culturally appropriate accommodation.

# **Section 9 - Conclusion**

The estimated number of accommodation units required to meet the needs of the Traveller Community within the lifetime of this Traveller Accommodation Programme 2025-2029 is 96 housing units. This programme outlines the existing and projected need for Traveller Accommodation and how Wexford County Council will meet this need. It outlines the policies in relation to Traveller Accommodation strategy for implementation and targets.

Wexford County Council is committed to working with Travellers, Traveller representatives, local communities and other agencies to deliver the programme and provide quality accommodation for members of the travelling community through LTACC. The implementation of this programme requires a commitment from all involved to work together. The proposals contained in the programme are also subject to the necessary funding being available.

This goes well beyond anti-racism and cultural awareness training (however necessary these are) and into the impact of this cultural awareness training on how things actually work. In other words, the effectiveness of efforts to communicate sensitively with this very marginalised and maligned community should not be measured by the amount of training or measures taken to mitigate this but rather by <b>the</b> <b>impact of this training and those measures from the perspective</b> <b>and lived experience of Travellers themselves</b> . This is not an initiative which would cost anything in monetary terms but which has the potential to restore trust and repair a damaged historic relationship between Travellers and the State creating the conditions for much more positive work going forward. This would be tangible both at the level of individual officials who work with the community and in the structures and procedures surrounding the accommodation process such as how forms are designed, how people are supported to understand and complete them and the availability of clear points of contact for specific issues such as safety on halting sites.
