# Minutes of the New Ross Municipal District Annual Meeting held on the 26th June 2024 at 14.30 hrs in the Council Chamber, County Hall, Carricklawn, Wexford

The District Manager took the Chair and welcomed all those in attendance, acknowledging the two newly elected Councillors, and the family members and guests attending the Annual Meeting.

An Cathaoirleach, Cllr Bridin Murphy, thanked the Members and stated that it was a great honour and privilege to be elected as Chairperson of the New Ross Municipal District for a second time by her colleagues, and that she looked forward to working closely with the Members and Officials over the coming year. She also stated that she hoped the Municipal District would continue building on its achievements of the proceeding 5 years by proactively working together as elected members, with the support of a dedicated executive, representing the people and communities of the District.

## 6. Eugene O'Neill Festival

unanimously agreed that both the Cathaoirleach, and Leas-Cathaoirleach, would travel to Danville, California, in September to represent New Ross Municipal District following receipt of the official invitation from Dan McGovern, Co-President, of the Eugene O'Neill Foundation.

The District Manager undertook to seek full approval for attendance as outlined, through the Plenary Session via the Corporate Policy Group as per standard procedures.
