	Proposal :	Permission for a development consisting of the installation of a cable duct and all other associated works above and below ground on a site of c. 0.02 ha. located at Crossfarnoge Bay Beach/Kilmore Beach. The cable duct will be installed below the surface of the dune system using Horizontal Directional Drilling (HDD), a modern drilling technique that minimises surface disturbance compared to traditional methods. This installation is required due to storm damage to existing cable ductwork at the same location, which has caused ductwork and associated infrastructure to become exposed on the beach at the base of the dune. The exposed element of the existing ductwork will be remediated. The anticipated duration for the works is three days. This application will be accompanied by a Natura Impact Statement (NIS)
